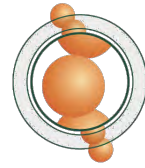

#### OVERVIEW

The Food Safety Modernization Act (FSMA) requires the U.S. Food and Drug Administration to undertake more than a dozen rulemakings and issue at least 10 guidance documents. The main provisions include biennial facility registration, foreign supplier verification programs, fees for inspection and increased inspection frequency. The law also provides FDA with new authorities, including mandatory recall authority and increased authority to detain food or suspend a facility's registration; require an imported food to hold a safety certification from an accredited third-party auditor; develop performance standards; the third party laboratory to be accredited.

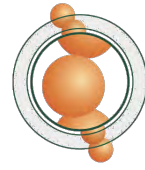
